Participation Rules, Guidelines, and Code of Conduct

The JCA afterschool program provides a warm, nurturing environment for young children grades K-5, where they have the opportunity to expand the learning of their school day, connect with peers, and build supportive, caring relationships with talented early childhood professionals. In addition to the diverse range of daily activities, specially designed for this unique age range, we offer a curriculum that revolves around exploring the outdoors, long term projects, creative art, athletics, science, performing art, cooking, and Jewish values. Following the rules and guidelines outlined below helps to ensure that we are a welcoming program to all members in our community.

- Students must be able to participate independently or with reasonable accommodations/modifications.
- Students must be age appropriate for the afterschool program.
- Students must be able to take and follow directions from staff members.
- Students must interact and participate in a manner that is physically and emotionally safe for themselves and others.
- Students must be able to maintain personal care and advocate for their needs.
- Students must be able to stay with their own group.
- Students must respect others (listening, following directions, using appropriate language, keeping hands and feet to self)
- Parents must be willing to work with the JCA staff and provide necessary information on their child's experience at school and in the afterschool program.
- Parents and staff must be willing to communicate with each other in a professional manner.

I have read and understand the above Rules, Guidelines, and Code of Conduct. By signing below, I am stating that I understand the participating rules and my child must abide by all of the above requirements. I understand that the JCA of Southern Maine staff reserve the right to discuss any questions or safety concerns about my child's experience in the afterschool program.
